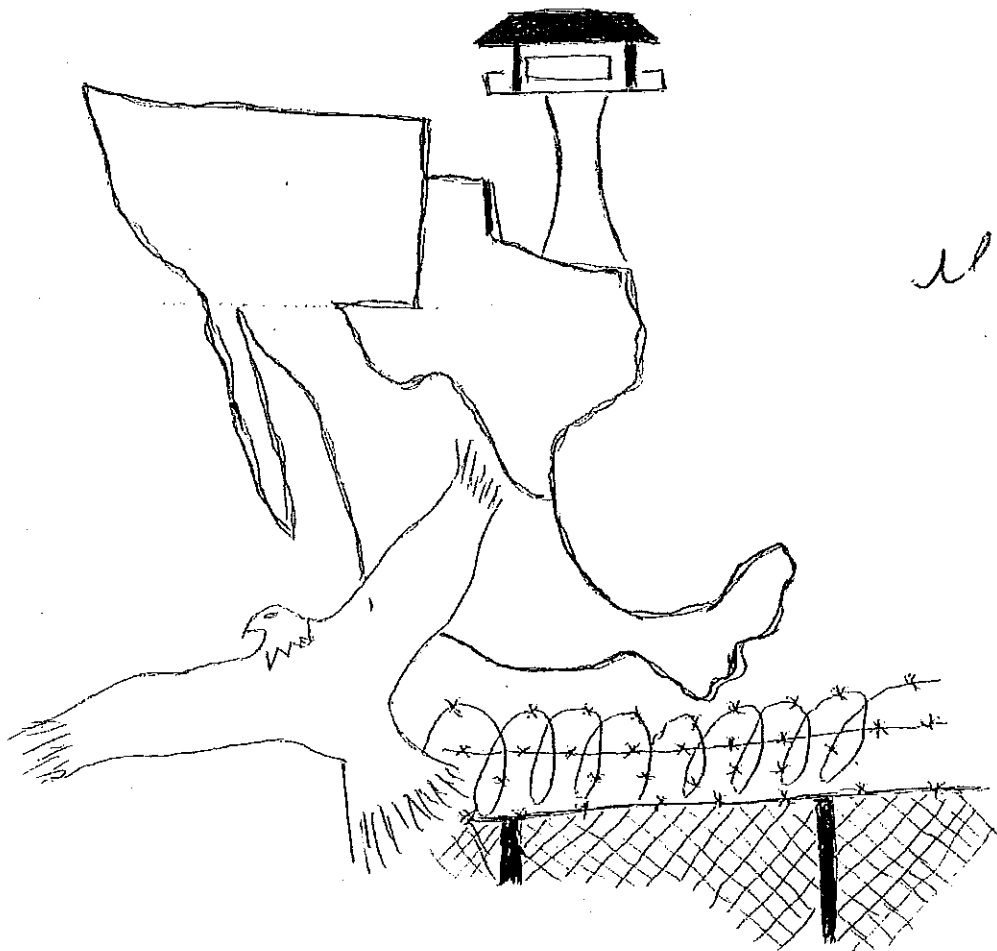

AN OPEN LETTER TO THE DIVERSE MOVEMENTS

DEAR COMRADES, ALLIES, FRIENDS, AND ALL OTHER JUSTICE & FREEDOM-LOVING PEOPLES OF THE UNITED STATES AND THE WORLD,

In the true spirit of human solidarity and internationalism against oppression, injustice and exploitation, I send all of you a warm embrace and greetings, with a clenched fist in the air, in this "Open Letter," from within the belly of a Supermax control unit prison, and under the bootheel of gestapo fascism behind razor wire and enemy lines, from this concrete tomb of one of Amerika's notorious gulag concentration camps for the poor, cages occupied by the poor, mainly by people of color who are disproportionately represented in the U.S. Prison Industrial Complex of Mass Incarceration for private, corporate profit, as sanctioned by the 13th Amendment to the U.S. Constitution that allows the immoral, criminal system of prison slavery that is destroying human lives, human dignity, by the same capitalist barbarians who rule the world and who are destroying the environment, ecological systems, and the wildlife of Planet Earth, for corporate, militarist profiteering.

The rise of fascism across U.S. cities, society and inside Amerika's prison houses has moved me to intensify my revolutionary advocacy work and reach outside these prison walls to persons and organizations like you, to stir the senses, to encourage those of you seriously concerned with our social and human condition as an oppressed class, and to step up and organize ourselves into the united, dynamic, creative social forces of resistance that we can, and must, build, in order to take control of our lives, our communities, and our destiny as Justice & Freedom-Loving, must work conscientiously to organize ourselves and fight back and replace this racist, rotten, immoral, repressive and imperialist political socioeconomic system of wage-theft capitalism and imperialism that is destroying human lives, human dignity and innocent civilians, and other abuses by authorities, by armed thugs of the state calling themselves "police," is widespread in all U.S. communities of color, from New York to California and in between. The police murders of Michael Brown, 12-year old Tamir Rice, Eric Garner, Walter Scott, Freddie Gray, Larry Jackson, and many other state-sponsored terrorist crimes against the innocent by armed thugs wearing badges, protected by racist courts, are not isolated incidents. It is a systemic pattern and culture of the core evils of this capitalist class socioeconomic system that is inherently racist to the core that must brutalize, coerce, control and exploit the working class in order to survive. This "Monster of Frankenstein" of this "free enterprise capitalist system" has entered its advanced form of repression called "fascism." Fascism is a system of government marked by a centralized oligarchy, stringent socioeconomic controls, nationalist patriotic frenzy, and the use of flagrant state violence against the poor and other segments of society it must scapegoat and to blame for the ills of the economic glut between capital and labor. All (14) characteristics of fascism are beginning to re-appear under the current capitalism that is inevitable under wage-theft slavery and the current "glut between capital and labor," that even the newspapers of U.S. corporations have recognized in an article

entitled, "Glut of Capital and Labor Challenges Policy Makers" The Wall Street Journal, 24 April, 2015, by Josh Zumbrun, and Carolyn Cut. Those characteristics are: (1) Powerful continuing nationalism, patriotic frenzy of the ultra-conservative extremism of the right-wing; (2) Disdain for human rights; (3) Identification of enemies, scapegoats as a unifying cause; (4) Supremacy of the U.S. military; (5) Rampant sexism; (6) Controlled mass media; (7) Obsession with national security; (8) Religion and government are intertwined; (9) Corporate power is protected; (10) Labor power is suppressed; (11) Disdain for intellectuals and the arts; (12) Obsession with crime and punishment; (13) Rampant cronyism and corruption, and (14) Fraudulent elections. See, "The Study of Fascist Regimes," By Dr. Lawrence Britt; further, the racist-hate murders of the [9] innocent black people during a "bible study" at the historic black church in Charleston, South Carolina by the racist extremist inspired by white supremacy and confederate slavery's history of the south; the "rally" by flag-waving confederate white supremacists through a black neighborhood in Houston, are just the "tip of the iceberg" of what is to come.

The political system, such as the U.S. Department of Homeland Security, the National Security Agency, the FBI, ICE, DEA, have long been operating "secret intelligence programs" and have "secret black hole prisons" around the world, as part of this fascist strategy. These agencies are sowing seeds of distrust, misinformation, and to divide and conquer communities of color, turning neighbors against each other, and creating "suspicions" amongst citizens and nurturing a culture of "snitches" of civilians spying on each other and reporting to government. These "intelligence agencies" are illegally wire-tapping private telephone lines, and spying on cyberspace communications and collecting other private and personal data and records from citizens by government randomly, especially those "suspected" of terrorism or terrorist-related activities, all in the name of "national security" and their "war on terrorism," which in all reality is "war on the poor," their "war on ethnicity and social dissent and protest." Under Obama's 2012 National Defense Authorization Act, the government can now arrest and detain citizens, indefinitely, without any charges or trial. Government is using this law to "criminalize" political free speech, and any legitimate act of opposition or "disloyalty" to government policies, and spy on citizens and groups the government dislikes, under false pretexts and in the name of "national security" as done against New York Criminal Defense Attorney Lynne Stewart for her legitimate "legal defense" of the blind Muslim Cleric convicted in the first World Trade Center bombings in New York City, now imprisoned in the Supermax Control Unit Federal Prison at (ADX)-Florence, Colorado, a prison the subject of many denunciations by renowned international human rights tribunals and world human rights groups. For example, U.S. federal and state prisons have also become "militarized." The majority of "prison guards" of the James V. Allred Prison Unit located near Sheppard Air Force Base in Wichita Falls, Texas, are either "retired military" or on "leave" to be redeployed to war zones around the world. Their arrogant "patriotism" shows in their sheer racist brutalities and inhumanities they commit against the captive population, especially against prisoners of the Islamic Faith who possess a "prayer rug" or a Holy Koran, or are labelled

"security threat group" prisoners due to their militant political ideas and are involved in protesting human rights violations in Texas prisons, much like this writer who has been in solitary confinement going on [13] years in August of this year, and is an internationally recognized political prisoner. See: www.thejerichomovement.com (List of Political Prisoners). The conditions here are not only inhumane, cruel and unusual punishment, but also constitute "torture" as condemned by the same federal judge that held them unconstitutional years ago in Ruiz v. Johnson, 37 F. Supp. 2d 855, at 940 (1999), original case at Ruiz v. Estelle, 503 F. Supp. 1265 (1980), in violation of international human rights laws and standards. The same "military police" responsible for torture, and other war crimes against detainees in military prisons in Guantanamo Bay, Cuba, in Abu Ghraib prison in Iraq, all learned their evil skills at "interrogation and torture" as "rookies" in state prisons. The hiring of former Texas prison director Lane McCotter, who ruled Texas prisons with an iron fist, by former U.S. Attorney General John Ashcroft, as "prisons director" at Abu Ghraib is a classic example. The world was exposed to the atrocities committed by military police at Abu Ghraib in photos and videos released recording these inhumanities and degrading treatment. Furthermore, the inter-connection between the government's intelligence programs and "Prisons and Prisoners" is clearly shown in the history of the government's "Red Squads" to spy on, monitor, infiltrate and destroy inside "prison movements" and assassinate prisoner-leadership militants who speak out against these inhumanities, who understand the true nature of prisons under capitalism, and link inside and outside struggles, as one. The recent 800 million dollars of taxpayer's monies earmarked for the militarization of the borderlands signed by Texas Governor Greg Abbott as the Republican's "Border Security Bill" are the realities we face. Under the guise of "National Security" fueled by racist right wing political propaganda targeting Mexicans and the undocumented, it is not about immigration and all about corporate profiteering. Such monies will be used to saturate the borderlands with more iron fences, walls, surveillance cameras, high-tech drone aircraft, motion-sensors installed underground, militarized weaponry and patrol boats, hundreds of Rambo-like, trigger-happy cops, and another secret "gang intelligence" program headed by the Texas "DPS" to spy on Texas prisoners, activist groups and citizens, including environmental groups, under pretexts. U.S. imperialism has a known history of manufacturing "reasons" for invading other countries, and declaring war against them. In Texas, these militarist moves are coming on the heels of allegations of political corruption and criminal securities fraud charges to be presented to a Texas Grand Jury by Special Prosecutors against Texas' "Chief Law Enforcement Officer" Texas Attorney General Ken Paxton, Republican, and his questionable cronyism hirings; and the separate allegations of "No-Bid Contracts" awarded to insurance and other companies as political cronyism favors to political donors from Texas Governor Greg Abbott, in his former position as Texas Attorney General, and the list goes on and on. The "arming" of alleged "Mexican Drug Cartels" under the federal government's "Fast and Furious" clandestine pro-

gram exposed by watch groups, was part and parcel of this overall fascist strategy to justify further social control, repression, militarization, and corporate profiteering by the U.S. Oligarchy. Earth First! The Journal of Ecological Resistance, Jun/July 2015, page 25, "Lawless Borderlands; Extensive Loss of Border Wild Lands to Immigration Madness," by Karen Coulter, put it eloquently: "...[T]he militarization of the border isn't so much about immigration as it is about social control, depressing of wages, and testing public tolerance for a police state as a pilot project in the south to be expanded to the north." The same capitalist corporate profiteers who have enriched themselves with building prison empires and the proliferation of "Supermax Control Unit Prisons" state and federal for our mass incarceration, are the same psychotic barbarians who are destroying the environment, ecological systems, wildlife and planet earth. We must stop this madness and wrestle political power and control away from them before it is too late. We must link our struggles against global capitalism, imperialist militarization, with our struggles to save the earth and all wildlife, its environment and ecological systems before the "world military super powers" initiate an apocalyptic nuclear war as a consequence of reviving global capitalist economies, and the re-division of world markets. We must not allow the establishment media to super-impose typical reformist "leaders" on our communities, for they are merely apologists of the capitalist system dispatched to mislead and to put out the "prairie fires" ignited across the nation, by oppressed people expressing their outrage and indignations against the brutalities, injustices, repression, and crimes against humanity of the capitalist police state against the poor. We must ^{not} do like the Ostrich and bury our heads in the sand, pretending these is not happening, nor seek other escapism from these realities that face us, and humanity. There is no way out of these nightmarish conditions but through revolutionary class struggle and resistance and to replace this illegitimate political system. History must be our teacher, our leader. Future generations will disown and condemn our generation if we fail to act now! Love, respect and give mutual aid support and solidarity to each other. Settle your quarrels and build a new and vibrant united front against fascism guided by, revolutionary theory, principles and practice, our social movements across the political, social spectrum must unite and take a leading, vanguard role in these inter-communal struggles, for building mass consciousness and mass mobilization of poor and oppressed communities, nationally and internationally. Seize the time! Build a united revolutionary front against fascism! Save the Earth! All power to the people! All power to the oppressed!

You are at liberty to share the contents of this communique with other persons and organizations in the United States and the world, in linking our community, worldwide and prison struggles against the same common enemy of the human species – global capitalism and imperialism!

CHICANO POW/POLITICAL PRISONER XINACHTLI, THE
CHICANO RESISTANCE MOVEMENT FOR SELF DETERMINATION
AND NATIONAL LIBERATION, AND THE CHICANO NATIONAL
AND COLONIAL QUESTION AND THE JERICHO POW/PP
SUPPORT MOVEMENT

The undersigned, as Coordinator of the COMMITTEE TO FREE XINACHTLI, COMITE' PRO-DEFENSA XINACHTLI, Austin-based, submits these comments, observations and suggestions penned by XINACHTLI from his solitary confinement cell in Texas prison, in response to Jalil's two-page proposal mailed to XINACHTLI, aka ALVARO LUNA HERNANDEZ, by the JERICHO LEGAL COMMITTEE, 320 6th Street, So. # 12, MOORHEAD, MINNESOTA, 56560, AS ATTACHED. The purpose of this paper is to provide some critical observations, analysis, criticisms, self-criticisms, and recommendations, on these pressing matters, with hopes of strengthening unity amongst THE JERICHO MOVEMENT, THE CHICANO RESISTANCE MOVEMENT, and other prison abolitionist, anti-fascist resistance and national liberation organizations and movements, AS A RALLYING CALL TO DIRECT ACTION against intensified social, racial, economic, and political oppression and repression in these crucial times confronting us, and the world, to resist and free ourselves from our slave, slave-master condition as WAGE-THEFT SLAVES of this capitalist system that oppresses us all. It is the hope of XINACHTLI, the COMMITTEE TO FREE XINACHTLI, and its undersigned COORDINATOR, that all forces of liberation within the U.S. and the world, come to its senses, "understand the reality of our situation" (COMRADE GEORGE L. JACKSON), come together in unity to support our imprisoned comrades languishing away in AMERIKKKA'S racist, inhumane, genocidal and tortures concrete tombs and cages, as victims of this U.S. government's "wars" against poor people's militancy and dissent and our diverse social, ethnic liberation movements for our universal emancipation from capitalist racist tyranny and oppression.

XINACHTLI (NAHUATL dialect meaning "Germinating Seed"), is now going on 15 consecutive years in solitary confinement in the notorious supermax high security control unit prison in Texas, also known as "THE GUANTANAMO OF TEXAS PRISONS." See PAUL SARATOFF, writer, MEN'S JOURNAL, March 2016 (on the exoneration of Texas prisoner CHRIS SCOTT for a crime he did not commit, www.men'sjournal.com). Not only does THE STATE OF TEXAS leads the nation in executions, but it also has a dismal record of imprisoning the "innocent," mostly PEOPLE OF COLOR, but TEXAS has a long history of brutal war crimes, plantation slavery, and maintaining a racist, and inhumane prison system of mass incarceration, all sustained by racist, brute prisoner slave labor in its "TEXAS CORRECTIONAL INDUSTRIES," and other conglomerate prison industrial enterprises, and of ongoing human rights violations that "shock the conscience." XINACHTLI'S wrongful political imprisonment, recognized by JERICHO and many other renowned national, international human rights activists and organizations, stems from him disarming a racist, abusive, violent Sheriff in ALPINE, TEXAS (a small, rural community located BETWEEN ODESSA and EL PASO, 90 miles from the US/MEXICO military-imposed border in far Southwest Texas), all in self defense. The Sheriff went to XINACHTLI'S home to arrest him on a bogus, false criminal charge, and without a lawful arrest warrant. When XINACHTLI questioned the Sheriff's illegalities, he became angry and was in the act of pulling his weapon, to shoot XINACHTLI, when XINACHTLI disarmed him and fled. The initial bogus charges were later dismissed when XINACHTLI proved his innocence in court, and a police conspiracy to frame him. The police had XINACHTLI under a "COINTELPRO-style" surveillance plot, that included use of government informants, and repeated harassment of him, all designed to stop XINACHTLI from organizing the Chicano barrios against a culture of police brutality and murders of unarmed, innocent Chicano Youth, and from fighting for social and racial justice for Chicanos, in a geo-political region of the U.S. Southwest occupied lands, known for its colonial racism and social oppression of Chicano people and "land grabs" of their homes, ranches, by land-hungry colonial usurpers who then, and now, continue to use "law" as one of their favorite weapons of racist tyranny and oppression against MEXICANOS, CHICANOS, such as the infamous saloon-courty of JUDGE ROY BEAN AND HIS "LAW WEST OF THE PECOS." See www.counterpunch.org/2011/05/16/the-ballad-of-alvaro-luna-hernandez/. XINACHTLI was sentenced to 50 years imprisonment by an almost all-white jury, with parole eligibility not until the year 2021, now going on 20 plus years of arbitrary and false imprisonment by "criminalization of militancy and dissent" and the use of extra-judicial means to declare those who oppose the U.S. government as

"perceived threats to national security and public order [.and.] domestic enemies," quoting page 27, SENATE SELECT COMMITTEE TO STUDY GOVERNMENTAL OPERATIONS WITH RESPECT TO INTELLIGENCE ACTIVITIES, and "the origins of COINTELPRO," popularly known as "The Church Committee." See THE COINTELPRO PAPERS: DOCUMENTS FROM THE FBI'S SECRET WARS ON DISSENT IN THE UNITED STATES, by Ward Churchill, James Vander Wall, 1990, Boston South End Press.

XINACHTLI'S activities in Alpine included his ongoing efforts to re-open the police murder of his friend ERVAY RAMOS, of June 12, 1968, by a racist Alpine cop, the tragic night XINACHTLI and RAMOS were "crusing" in RAMOS'S car, police giving chase to the vehicle, stopping the car after a police chase and police shooting RAMOS in the back as he attempted to flee the scene, killing RAMOS instantly, and XINACHTLI witnessing the cold-blooded murder. As is common in racist courts that protect murdering police, and the long tradition of the "police occupation armies" enforcing white settler colonial rule, the murdering cop BUD POWERS (deceased) never served a day in jail. The RAMOS CASE was chronicled, inadequately, in a 1970 report of the U.S. Commission on Civil Rights, entitled: MEXICAN AMERICANS AND THE ADMINISTRATION OF JUSTICE IN THE SOUTHWEST, Library of Congress. Since murder has no statute of limitations, ALPINE POLICE knew XINACHTLI was [in their own words] "agitating citizens" to oppose police brutality, to stand up and to assert their civil and human rights, and to unite against social and racial oppression by police and the white-dominated economic and political establishment, where Chicanos made up fifty per cent (50%) of the county's populace, but had no political voice and continued to suffer the vestiges of colonial rule, institutional racism, racial segregation and white supremacy, all "Amerikkkan traditions" since the founding of this nation; capitalist expansionism and the continued enslavement of the BROWN, BLACK AND INDIGENOUS INTERNAL COLONIES of U.S. Yankee colonialism, neo-colonialism, capitalism and imperialism, since the "pilgrims" landed at Plymouth Rock, and the U.S. colonization of Northern Mexico through wars of colonial plunder, modern-day capitalist expansionism and imperialism. Upon his arrival in Alpine from Houston, police immediately placed XINACHTLI under COINTELPRO-type surveillance, for police knew of XINACHTLI'S history of community organizing in Houston, his successful civil rights suits against police, and his human rights work in oppressed Chicano barrios, recognized by many Chicanos in the barrio as a fierce advocate for human rights, a freedom fighter and a symbol of Chicano Resistance in the occupied territories of the U.S. Southwest. XINACHTLI appeared frequently as an invited speaker at forums, events, protest marches, and television and radio shows to speak on his work as Coordinator of the RICARDO ALDAPE GUERRA DEFENSE COMMITTEE, Houston, that led the struggle to free Mexican undocumented national GUERRA from Texas' death row for killing a Houston cop he was totally innocent of, during times of the "fascist frenzy" of a political climate of anti-Mexican, anti-immigrant hysteria and violence against immigrants by the racist, fascist forces of rightwing reactionary violence against immigrants, Muslims and people of color, we are again seeing now WITH THE RISE OF WHITE SUPREMACY AND CORPORATIVIST FASCIST CAPITALISM AND IMPERIALISM, that have our communities of color under police, military siege. Police feared the fearless, charismatic XINACHTLI as he had had

prior shootouts with police, had liberated himself and all other prisoners from the notorious PECOS COUNTY JAIL in Fort Stockton, TX protesting a crime he did not commit, and had created a rejuvenated SPARK OF RESISTANCE AND MOBILIZATION in Chicano Mexicano barrios in Houston, reminiscent of the nostalgic times of the peak of the CHICANO MOVEMENT DAYS immemorial in the recorded history of people's liberation struggles against their oppressors. These, and other reasons, are why police targeted XINACHTLI, for either assassination or wrongful political imprisonment. THEY CAN JAIL REVOLUTIONARIES, BUT NEVER REVOLUTION !

PRIOR TO THE CONFRONTATION WITH ALPINE POLICE, XINACHTLI had been a prisoner-petitioner at both the SPECIAL INTERNATIONAL HUMAN RIGHTS TRIBUNALS, held at New York's Hunter College, December 1990, and the one in San Francisco, in 1993, sponsored by the MOVIMIENTO DE LIBERACION NACIONAL MEXICANO, that seems to have fizzled in obscurity with changing political winds, intellectual chaos, a deep identity crisis, and the demise of the Chicano revolutionary movement and left-wing movements in the U.S. with state repression. Both tribunals condemned the illegal occupation of Mexicano Chicano lands, the U.S. colonization of Northern Mexico, and reaffirmed the inalienable right of Chicanos to armed struggle to free themselves from the colonial criminal system, of their right to self determination, national liberation and the return of their stolen homelands; for the release of all Chicano political prisoners, and for reparations for such colonial war crimes, crimes against humanity against CHICANO PEOPLE by U.S. Yankee colonialism and imperialism, and the return of their homeland, in accordance with NUREMBERG WAR CRIMES TRIBUNAL principles of international laws, including the creation of A TRUTH AND RECONCILIATION COMMISSION to uncover a steel veil of colonial, imperialist lies, genocidal massacres, lynchings, stereotypes, social myths, for colonialism "turn[ed] to the past of an oppressed people, [to] distort, disfigure and destroy" Chicano Mexicano people, as exposed by FRANTZ FANNON in his book, THE WRETCHED OF THE EARTH, collective traumatic crimes of colonialism and imperialism. See LET FREEDOM RING: A COLLECTION OF DOCUMENTS FROM MOVEMENTS TO FREE U.S. POLITICAL PRISONERS, by Matt Meyer, 2008, PM PRESS; and CAN'T JAIL THE SPIRIT, Editorial Caracol, 2002 (both books profiling in part XINACHTLI'S HISTORY OF RESISTANCE, WRONGFUL IMPRISONMENT). See also www.freealvaro.net.

CHICANOS, MEXICANOS have a rich history of resistance against U.S. Yankee colonialism and imperialism including waging guerrilla war against the war criminal occupation of their homeland, as testament in the 1915 REVOLUTIONARY PLAN OF SAN DIEGO, TEXAS and a call for all Chicanos, and African Americans to join the armed struggle for freedom from plantation slavery and for the creation of free Republics in the South, free of white racist, slave masters. The movement was violently repressed by the colonial government and other racist, vigilante groups working "hand in glove" with colonial war criminal governments led by the U.S. government. Despite the treacherous, false promises of the 1848 TREATY OF GUADALUPE HIDLAGO, an illegal treaty negotiated at the point of a gun, that ceded the currently occupied territories of TEXAS, NEW MEXICO, ARIZONA, CALIFORNIA, COLORADO, and parts of NEVADA AND UTAH, that ended the MEXICAN-AMERICAN WAR, these war crimes, crimes against humanity have gone unpunishment. Many unmarked graves exist throughout the U.S. Southwest, and this government's "war of ethnic cleansing" against MEXICANOS, CHICANOS, that must be

confronted and resolved. The TEXAS RANGERS, FBI, CIA, and vigilante groups at their service, have waged, and continue to wage "war" against CHICANO PEOPLE since the occupation, to today, intensified now by the "POLITICS OF TRUMP" and the rise of WHITE SUPREMACIST FASCISM. Progressive, abolitionist, anarchist, revolutionary, anti-fascist resistance organizations must address the CHICANO NATIONAL AND COLONIAL QUESTION within TRUMP'S FASCISM to bring historical, intellectual and ideological clarity to our oppressed barrios, favelas, ghettos and communities, that will inspire, and create the SPARK OF A PRAIRIE FIRE THAT WILL "ARM THE SPIRIT OF RESISTANCE." To reject these pressing questions is to contribute to the ineptness and bankruptcy of our liberation movement[s] and left-wing forces that permitted TRUMP to now sit in THE WHITE HOUSE. YANKEE COLONIAL, AND STATE REPRESSION AGAINST THE MEXICANO, CHICANO PEOPLES IS A CONTINUATION OF THE "CLASS WAR" WE SEE TODAY, SPECIALLY IN THE BORDERLAND STATES. Any "movement" that ignores these questions, IS A SHAM MOVEMENT. See THE CRUSADE FOR JUSTICE: CHICANO MILITANCY AND THE GOVERNMENT'S WAR AGAINST DISSENT, by Ernesto Vigil, 1999, UNIV. OF WI PRESS: XINACHTLI is a Chicano POW representing the CHICANO MEXICANO REVOLUTIONARY MOVEMENT AGAINST YANKEE COLONIALISM, CAPITALISM AND IMPERIALISM. He deserves the unconditional support of all freedom and justice loving peoples of the U.S. and the world. He was targeted for assassination, and/or political imprisonment while acting in his capacity as "NGO" (nongovernmental organization) delegate and "field investigator" to document, bring human rights abuses by the U.S. GOV'T before the UNITED NATIONS COMMISSION ON HUMAN RIGHTS, as he had done before in MARCH-APRIL 1993 where he personally addressed the U.N. GENERAL ASSEMBLY and denounced domestic human rights violations by the U.S. GOV'T, at Geneva, Switzerland, 49th Session, that included a call for release of all U.S. POW/PPS, sponsored by the NGO INTERNATIONAL INDIAN TREATY COUNSEL, SF, and the NAT'L CHICANO HUMAN RIGHTS COUNSEL, CO. XINACHTLI is, therefore, entitled to immediate release under U.N. "diplomatic immunity" laws, and entitled to reparations for being wrongfully imprisoned as an innocent man, CRIMINALIZED BY THE U.S. POLITICAL POLICE STATE apparatus to silence him. He is now being tortured, and subjected to WITCH HUNTS, harassment, repression by the prison political intelligence police, caged in a supermax high security control unit in Texas prisons, suffering a SLOW MURDER BY MEDICAL NEGLECT as the State of Texas denies him life-threatening anti-virus HEPATITIS C medicines to cure his illness, hoping it will kill him, as they murdered lead prisoner-plaintiff DAVID RUIZ, of the historic RUIZ V. ESTELLE prison conditions case, to silence prisoner militancy and dissent; as XINACHTLI continues his denunciation of TEXAS PRISON SLAVE LABOR, MASS INCARCERATION, HUMAN RIGHTS VIOLATIONS IN TEXAS PRISONS, with calls for WORKING CLASS/PRISONER UNITY and social revolution against U.S. Yankee colonialism, neo-colonialism, capitalism and imperialism, in his many letters, writings, manifestos, and his justified and fierce diatribes written and distributed from his prison solitary confinement cage and concrete tomb, all under the boot heel of naked prison fascism and suppression and censorship. XINACHTLI has been a symbol of prisoner unity, solidarity and resistance for many years, beginning as a self-taught "jailhouse lawyer," and founder of PRISONERS UNITED FOR REVOLUTIONARY EDUCATION (PURE), to study the selected works of COMRADE GEORGE L. JACKSON, the ATTICA PRISON REBELLION, and honor the martyrs, heroes of PEOPLE'S LIBERATION MOVEMENTS AND WORKING CLASS REVOLUTION, and to: TRANSFORM THE CRIMINAL MENTALITY INTO A REVOLUTIONARY MENTALITY, as called for by COMRADE GEORGE in his historic book, BLOOD IN MY EYE, that remains relevant and is a BLUEPRINT FOR OUR LIBERATION TODAY! Xinachtli's prison activities can be read in: JAILHOUSE LAWYERS, pgs. 223-24, by Mumia Abu Jamal, 2009, CITY LIGHTS BOOKS; and at HERNANDEZ V. ESTELLE, 788 F. 2d 1154 (5th Cir. 1989)(on work strike, censorship). THEREFORE,

THE COMMITTEE TO FREE XINACHTLI, hereby resolves and declares, pursuant to, and in total support of JALIL'S PROPOSAL, TO ACCOMPLISH THE FOLLOWING, CALLING ON ALL LIBERATION GROUPS AND MOVEMENTS TO JOIN TO:

1. Build a national determination focused on petitioning renowned, progressive international jurists to initiate a HUMAN RIGHTS VIOLATIONS INVESTIGATION of all cases of JERICHO LISTED POW, POLITICAL IMPRISONMENT, AND THE CONDITIONS OF SOLITARY CONFINEMENT OF OUR IMPRISONED COMRADES AND FREEDOM FIGHTERS, INCLUDING TO APPROACH THE U.S. CONGRESS with a request to re-open COINTELPRO HEARINGS AND INVESTIGATIONS under a similar CHURCH COMMITTEE CONGREGATION FOR THE UNCONDITIONAL RELEASE OF OUR POW/PPS;
2. Create a political environment to build INTERNATIONAL SOLIDARITY among progressive, liberationist forces around the world, and to organize a contingent of citizens, and supporters of U.S. political prisoners, to approach their U.S. EMBASSY in their own countries and lodge formal human rights complaints against the U.S. Government protesting the continued arbitrary detention and torture and wrongful political imprisonment of our U.S. freedom fighters and political prisoners, in both state and federal prisons;
3. Build a media/propaganda campaign using all mediums of outreach, such as social media, #hashtag blocks, facebook, twitter, to publicize the plight of our imprisoned freedom fighters, and condemn the inhumane conditions of their confinement to them and the risks they face to their lives from the denial of life-threatening medical care and treatment as a form of genocide as most of our comrades are PEOPLE OF COLOR;
4. Expose the persistent, ongoing blatant hypocrisy of the U.S. human rights record, its continued violations of the NELSON MANDELA RULES, and other UNITED NATIONS HUMAN RIGHTS LAWS AND STANDARDS AGAINST ARBITRARY DETENTION, TORTURE, EXCESSIVE USE OF SOLITARY CONFINEMENT AND DENIAL OF MEDICAL CARE and the ongoing physical and psychological damage and torture to them;
5. strengthening our unity and support of our imprisoned comrades, as mentioned in the JALIL PROPOSAL, attached, as well as contacting other progressive, abolitionist, liberations movement organizations to support the JERICHO POW/PP SUPPORT MOVEMENT and advocacy for the release of all of them, including XINACHTLI and to incorporate the CHICANO NATIONAL AND COLONIAL QUESTION and the DECOLONIZATION of the occupied territories in the U.S. Southwest under military siege, as well as the creation of a REPARATIONS, AND TRUTH AND RECONCILIATION COMMISSION comprised of renowned international jurists to remedy all COINTELPRO persecutions, and reparations for all victims of U.S. YANKEE COLONIALISM, NEO-COLONIALISM, CAPITALISM AND IMPERIALISM in the U.S. government's war against social, political militancy, and dissent in the United States.
6. Make JERICHO, and its JERICHO LEGAL COMMITTEE more sensitive to, responsive and inclusive of all POW/PPS, on a wide, broad basis and not pursue a selective, favorite-status for certain imprisoned comrades based on "celebrity status," race, color, or political affiliation

and not act in an isolationist, sectarian manner, in serving the legal, spiritual, medical, and political support needs of all of our imprisoned comrades, and represent them all fairly, equally, and totally, and be responsive and accountable to them AND PRACTICE WHAT WE PREACH; all in loyalty to our diverse liberation movement[s], and to the WORKING CLASS REVOLUTIONARY MOVEMENT AGAINST COLONIALISM, NEO-COLONIALISM, CAPITALISM AND IMPERIALISM OF OUR ANTI-RACIST, ANTI-COLONIAL, ANTI-CAPITABIST, ANTI-IMPERIALISM, ANTI-PRISONS FOR CORPORATE PROFIT, ANTI-FASCIST MOVEMENT[S] and support of our imprisoned comrades, within the belly of the beast. ADDRESSING THESE CRITICAL, AND PROFOUND QUESTIONS WILL MAKE OUR LIBERATION MOVEMENT ORGANIZATIONS MORE CREATIVE, DYNAMIC AND STRONGER:

Colonialism, Resistance in The Southwest U.S.

Mexicanos, or Chicanos, came under U.S. Gov't rule after white colonial settler wars of expansionism beginning in the 1800's to today. These colonial wars robbed 50% of Mexico's northern territories annexing it as the U.S. Southwest. After the conquest, occupation, brutal policies of extermination and repression of Chicanos continued in the occupied lands, that included mob lynchings, and "ethnic cleansing" race killings. Mock "kangaroo courts" such as the infamous "LAW WEST OF THE PECOS," saloon-court of tyrant "Judge ROY BEAN" were set up by land-hungry usurpers to "legalize" their land-grabs and colonial war crimes against Chicanos. It was "open season" against Chicanos, even after the false promises of the 1848 Treaty of Hidalgo, an illegal treaty negotiated at the point of a gun, that ceded this land mass, TEXAS, NEW MEXICO, ARIZONA, CALIFORNIA, COLORADO, parts of NEVADA, UTAH, ending the Mexican-American War of 1848. The U.S. GOV'T and its domestic terrorist militia, the brutal TEXAS RANGERS police army killed over 20,000 RAZA in acts of state terror in order to exterminate them, and make them flee their homes, ranches to the South of the new military border set by criminal acts of war. Chicanos, Mexicanos have always fought valiantly against the war criminal occupation of their homeland. Among the most famous resistance fighters were JOAQUIN MURIETTA, JUAN CORTINA, TIBURCIO VASQUEZ, MELCHOR OCAMPO and others who waged guerrilla warfare against the colonial government, from Texas to California. In 1915 the "REVOLUTIONARY PLAN OF SAN DIEGO, TEXAS" was a call for armed struggle for liberating the occupied lands. It called on African Americans to join the armed struggle for their own liberation from plantation slavery in the South, for the creation of a NEW AFRICAN REPUBLIC side by side with the NEW REPUBLIC OF AZTLAN. The armed movement was violently repressed by the GOV'T and vigilante groups. In contemporary society, the TEXAS RANGERS continued to enforce

colonialism ruling Chicano barrios with an iron fist. Many CHICANO MOVEMENT leaders, and groups were assassinated, or jailed from REYES LOPEZ TIJERINA, RICARDO FALCON, REYES MARTINEZ AND THE "BOULDER SIX," RUBEN SALAZAR, RICARDO ROMERO, FRANCISCO "KIKO" MARTINEZ, and many more. The same counter-intelligence beast has risen its ugly head again, post SEPTEMBER 11 under the direction of HOMELAND SECURITY. State repression against Chicanos continues today, intensified by the election of fascist pig DONALD TRUMP and his ghoul, theocrat, white supremacist, evangelical reactionaries and billionaires who now rule U.S. society and government. NO FASCIST WALL !

Chicanos Are An Internal Colony of U.S. Imperialism

There is a high incidence of poverty, infant deaths, malnutrition, youth crime, police brutality, a proliferation of dangerous drugs in Chicano barrios (50% of RAZA are in prison for drug offenses). Chicanos continue to be stereotyped, gentrification of their barrios, racially profiled by police, and forced assimilation is the rule in White Racist Amerikkka, aimed at destroying their culture, language and other indigenous customs, traditions, despite the treacherous HIDALGO TREATY. Chicanos living within the borders of the occupied territories, are entitled to exercise their inalienable right to self determination, national liberation and to wage armed struggle to free themselves from colonialism, neo-colonialism, capitalism and imperialism, as guaranteed by UNITED NATIONS, THE LAWS OF NATIONS, and other international human rights laws declaring colonialism a crime against humanity. At least two special tribunals organized under NUREMBERG WAR CRIMES CHARTERS, have ruled in favor of Chicanos and the decolonization of their occupied lands, for release of Chicano prisoners, and for reparations for these war crimes. See LET FREEDOM RING: A COLLECTION OF DOCUMENTS TO FREE U.S. POLITICAL PRISONERS, BY Matt Meyer, 2008, PM PRESS (documenting XINACHTLI'S case of wrongful political imprison-

ment). The U.S. AND TEXAS GOVERNMENTS have never been punished for these horrific war crimes against Chicanos. Their "war" continues today, now on the "immigrant front," and the frenzy of TRUMP and his right wing anti-Mexican, anti-immigrant attacks and his plans to "build a wall" at the US/MEXICO border, from Brownsville to San Diego, CA. XINACHTLI is an anti-imperialist freedom fighter, with a long history of resistance, inside and outside prison walls. He was framed by the police to silence him, and sentenced to 50 years for disarming a racist, violent Sheriff who was in the act of murdering him. He is now going on 15 consecutive years in solitary at the Allred neo-colonial prison. He is very active in the prison abolitionist, liberation movement. TEXAS IS SLOWLY MURDERING HIM BY MEDICAL NEGLECT as he is in dire need of HEPATITIS C medicines to cure his illness, that is life-threatening. THIS GOV'TS LIES THAT IT HOLDS NO POW/PPS MUST BE EXPOSED. THERE ARE HUNDREDS OF IMPRISONED COMRADES VICTIMS OF COINTELPRO PERSECUTIONS. Many have died in prison. Their legitimate actions at self determination for their oppressed communities were CRIMINALIZED by the GOV'T. and its POLICE POLITICAL STATE. THE U.S. GOV'T is the chief violator of human rights domestically and around the world, and its hands drip with the blood of our fallen martyrs, too many to list here. WE MUST SUPPORT AND DEFEND XINACHTLI, AND ALL OUR IMPRISONED COMRADES, AND CELEBRATE THEIR PERSONAL SACRIFICES AND HEROISM.
